Jeff Kingsley gave the board a Petition with 142 signatures to re-zone Goose Bay Fire protection. Mr. Kingsley talked about a fire that started at a neighbor's house near his home in Goose Bay and he stated that if it wasn't for the Alex Bay Fire Department acting quickly the surrounding houses would have all caught fire. Kingsley discussed with the board why he feels re-zoning the fire protection area would be beneficial for the Goose Bay residents.
