Call the town board meeting to order at 6:00 pm by Supervisor Sweet

PLEDGE OF ALLEGIANCE

Councilman Thomas - Absent

Motion by Supervisor Sweet to pay October 2023 abstract bills along with the two bills for November, one for USDA and the other for H and H, minus the bill for the Redwood Cemetery and minus the Assessor's bill.

He stated that he did have a question about the Redwood Cemetery bill for 2023-24 and questioned why the town pays in advance for the \$125 for maintenance of the cemetery. Board members discussed the cemetery and asked where it was located and if it was still active. It was agreed to hold off on that bill until more questions are answered.

Councilman Fayette questioned why the assessor wasn't being paid and questioned how the town could not pay him.

Councilman Thomson explained that he is going to be paid, just in a different form. He will be paid on the payroll.

Motion was seconded by Councilman Kring and carried with all voting in favor thereof.

Motion was made by Councilman Fayette to approve the board meeting minutes of September 20, 2023, September 21, 2023 and October 2, 2023, seconded by Councilman Kring and carried with all voting in favor.

Motion was made by Councilman Fayette, seconded by Councilman Kring to open the public hearing to hear comments in connection with Local Law No.4 of 2023, a Local Law to Override the 2024 Tax Cap Limit.

Supervisor Sweet explained that this is to override the tax cap. While, the board doesn't think it will be needed, they were advised to pass it anyways. Last year, the town board didn't need to use it.

There was no public comment.

Motion was made by Councilman Thomson, seconded by Councilman Fayette to close the public hearing.

Motion was made by Councilman Thomson, seconded by Councilman Kring to pass Local Law No. 4 of 2023 to override the 2024 Tax Cap Limit.

Public Comments

There were no public comments.

Engineer Report

Rob Campany explained that the bonding for the Redwood work requires him to send engineering reports. which are completed, to Tim, the bond counsel as well as to Jeff Smith with Municipal Solutions. He explained that Tim will then prepare a resolution for the board's November meeting, which will require a public hearing, which can be held in December after which the resolution can be voted on. Since it is a 202B process, it is a simpler bond resolution process. Then permanent bonding can be put in place. SEQRA short form will also have to be done. He also commented that the outside of the water tank will have to be painted at some point. So much delamination has occurred that it will have to be a complete removal of the paint, with an estimated price of around \$300,000

Supervisor Sweet remarked that he has been asked about the Butterfield Lake pavilion placement. Rob explained that Steve Dorr is the only one so far that has been looking at it. Rob thought that perhaps others would be looking at it later when not so busy.

Rob explained that he reached out to EFC on additional funding applied for regarding the Route 12 sewer. It was suggested that we break this up into two phases. We are waiting for feedback to see if that would make it eligible for the funding. In addition, since the town has a pending application for funding for a water improvement grant through DEC, they won't talk with us about the application, and we won't know until late November or early December how we scored. He also explained that one of the problems with EFC current funding program, is that we couldn't have incurred any debt on the project prior to a certain date in 2021. We had a note on that project that was closed prior to that date and consequently, they couldn't extend the funding under that program. He explained that all the details haven't been worked out in regard to the debt issues for the district.

Rob explained that the Otter Street sewer extension requires RFP for engineering services and they had submitted a proposal on September 6th. The town board responded that they had received the proposal from St Lawrence Engineering.

Motion was made by Councilman Thomson that the proposal by St Lawrence Engineering for the Otter Street Sewer Extension planning report and study project be approved. Motion was seconded by Councilman Kring and carried with all voting in favor thereof.

Highway Report

Supervisor Sweet advised that Swan Hollow and Barnes Settlement roads are complete and all that is needed is some signage. Progress is being made on the Dorr Road. Crews will then move to the Hanni Road for minor repairs. They will soon be installing winter road reflectors and tearing down trucks. They are searching for part time winter help. The report indicated that the pay has to be raised or allow the superintendent to hire a full-time MEO. It also stated that they can not take a truck off the road as it will result in much more overtime.

Councilman Kring advised that Justin Schultz is going to come back and another part time person was hired.

Zoning Report, Water Report, Sewer Report, Arena/Youth Report

These reports are backup documents that can be found on the town's website.

Water and Sewer Committee Report

Sandy followed up on Mr. Vien's complaint concerning the charges on the lot next door. He said that he had been told by Supervisor Hunneyman and Sewer Operator Dana Spies, that if he cleaned up the house and combined the lots, there would be no additional charges. He said that Mr. Spies was supposed to remove the sewer pots but did not come when Rusty Johnson was there because he said he was busy and would do it later. Sandy explained that she spoke with Dale and he doesn't remember this agreement. She also checked the minutes for the years that Dale was supervisor and there is no mention of it there either.

Sandy stated that the water and sewer bills have gone out and are due by October 31st and she is currently working on the re-levy for those accounts that are in arrears. She has been working on the water and sewer districts based off the tentative budget. The proposed capital amounts as of now: Redwood water district would be \$330, the same as last year. Redwood sewer would be \$80 – down \$5 from last year; Route 12 water with her recommendation would be paying \$330 – down \$80 from last year due to increase in units; Otter Street water would tentatively be \$436 up from \$410 last year.

Supervisor Sweet asked what the current policy is for removing sewer pots. Councilman Fayette remarked that the owner is responsible.

Sandy responded that the current policy is that it is the owner's responsibility. And, Mr. Vien had stated that he had Rusty Johnson's crew there taking things out and he would have had them take the pots out if that's what the agreement was.

Councilman Fayette asked Rob Campany if the town could remove infrastructure that they are still bonded for. Rob responded that it's a good question, however, he's not sure who would answer it. Supervisor Sweet suggested that Jeff Smith would probably know the answer.

Councilman Fayette commented that this has come up before on the maintenance side of it. When the original rate was set based on a certain number of edu's so if we remove something, that changes the number of edu's.

Sandy explained that he had the house torn down and under the new ordinance, because the infrastructure is still there, he is being charged for ½ edu.

Supervisor Sweet stated that he would contact Jeff Smith and the Association of Towns in regard to this issue.

Clerk Report

Sandy stated that monthly reports were submitted on time, and she has been working on a lot of water and sewer things and stuff for the county.
